Committee Updates

Finance

- Reviewed Budget vs. Actuals (March)
 - Approval of budget vs. actuals for March. CS motions to approve, PS seconds, no abstains. All in favor. None opposed.
- Reviewed 24-25 Budget
 - Funding is going up \$180 per student next year. That is reflected. 1 out of state student
 - Lease aid has to be applied for every September. We can get it for the portion of time we don't own the building
 - CSP Grant- computers, furniture, software
 - Teachers line items include two new teachers and additional specials teachers hours
 - Added part time person coming in to help with the front desk
 - Added project manager- yearbook, handbooks, project focused items
 - Additional RT 1 and Title 1 funding to provide more support
 - Increasing the amount of people eligible for benefits and how to offer benefits to them-
 - Currently only Full time salaried professionals

- Hope to offer it to hourly employees- specials teachers and office staff
- Benefits went up 10% from last year
- Increase company match to 3% with a financial advisor coming in August to provide more information. Currently at 45% participation but would like to encourage more
- Approval of Budget for the 24-25 year. CM motions to approve, MG seconds, no abstains. All in favor. None opposed.
- To make sure that there is always someone available to sign checks in case someone is away or unavailable, DR and BA will be appointed.
 - Approval of DR and BA as check signers. PS motions to approve, MG seconds, no abstains. All in favor. None opposed.
